1	Group Projects and Team Presentation - The class will be divided into two or three teams (given current class size). Each team will be given the same set of financial tasks based on material covered in class and required to make an oral presentation to the class, as well as a written presentation on their findings. Both quality of analysis and quality of presentation will determine grades or this exercise.
2	Exams - The scheduled exams will consist of financial problem solving exercises and analyses and/or essay questions. Exam dates are provided on the class schedule.
3	Rreading Assignment and Case Study — If you hand in a paper after its due date, your grade for the assignment will be reduced by 10 points (on a scale of 100) if it is one class late, 25 points if it is two classes late and 50 points if it is three classes late. No credit will be given if it is handed in beyond that time frame. The one exception to this policy is that you may select one and only one paper for which you will be granted a grace period allowing you to hand in the assignment one week late without loss of credit. You must e-mail me that you are taking your grace period before the assignment is due. Papers are due at the start of class on their scheduled due date. If you e-mail me your assignment, I must receive it before the start of class; if you e-mail it to me after class on its due date, it is one class late.
